

Financial Report Year Ended 30 June 2018

Mr President and Members,

It is my pleasure to present the Treasurer's Report for the previous financial year.

Attached is the audited Financial Statement, comprising the Balance Sheet and the Income and Expenditure Account, for the period 1 July 2017 to 30 June 2018.

The Society is registered for GST. This registration includes each of the State chapters, and the Society submits quarterly business activity statements. The Society also has tax free status under an interpretation of ATO rulings, relating to Australian industry promotion.

The National account deficit for the year was \$15,543.01 (including returned seed funds from EECON18 and EECON18), compared to last year's deficit of \$77,389.50 (which included outgoing seed funds to the two EECONs). Income from subscriptions increased, and Term Deposit interest is reduced, as funds were withdrawn from two as they matured.

The State Chapter accounts have again been included in the audit process. Balance Sheets and Income and Expenditure Statements for each Chapter, and a combined summary sheet for the Chapter accounts, are included. The Victorian chapter result is inflated as the National profit share has not yet been transferred. The result for the Queensland chapter reflects the very successful EECON18.

The overall financial position of the Society remains very healthy.

I wish to propose that:

- 1. the attached Accounts to 30 June 2018 be adopted
- 2. Nina Dillon of Goulburn, be re-appointed as Auditor for the forthcoming year 2018 / 2019.

Note 1. Statement of Accounting Principles

The Society accounts on an accrual basis of accounting rather than the cash basis.

The entity is not a reporting entity because in the member's opinion there are unlikely to exist users who are unable to command the preparation of reports tailored so as to satisfy specially all of their information needs, and these accounts are therefore "Special Purpose Financial Reports"

The entity has applied the Reporting Entity concept and in the opinion of the members no Accounting Standards have mandatory applicability.

The financial statements have been prepared in accordance with the historical cost convention. The accounting policies adopted are consistent with those of the previous year except as otherwise stated.

Because of the legal standing of the member's subscriptions, no accrual of outstanding amounts is made.
